

ORDINANCE NO. - 277

AN ORDINANCE OF SOUTH HEIDELBERG TOWNSHIP, BERKS COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 123 WHICH ESTABLISHED REGULATIONS REGARDING THE OPERATION OF MOTOR VEHICLES WITHIN THE TOWNSHIP, SECTION 7 ENTITLED "MAXIMUM SPEED LIMITS ESTABLISHED ON CERTAIN STREETS", TO ESTABLISH NEW SPEED LIMITS ON KRICK LANE, MOUNTAIN HOME ROAD, LINCOLN DRIVE, BELLE ALTO ROAD, NORTH GALEN HALL ROAD, AND HUNTZINGER ROAD AND TO AFFIRM SPEED LIMITS ON BALTHASER ROAD, OLD WEST PENN AVENUE, SPORTSMAN ROAD AND WALTERS AVENUE.

WHEREAS, South Heidelberg Township, Berks County, Pennsylvania (the "Township") enacted Ordinance No. 123 which established regulations regarding the operation of motor vehicles within the Township; and

WHEREAS, Spotts, Stevens and McCoy, the Township Engineer, completed an engineering study to establish appropriate speed limits on segments of six (6) Township roads, including Krick Lane, Mountain Home Road, Lincoln Drive, Belle Alto Road, North Galen Hall Road, and Huntzinger Road; and

WHEREAS, the Township Board of Supervisors hereby adopts the recommended speed limits established as a result of the engineering study.

BE IT ENACTED AND ORDAINED by the Board of Supervisors of South Heidelberg Township, Berks County, Pennsylvania (the "Township") and it is hereby enacted and ordained by authority of the same:

SECTION 1. Ordinance No. 123, Section 7 entitled "Maximum Speed Limits Established on Certain Streets", is hereby amended and restated in its entirety, as follows:

Section 7. Maximum Speed Limits Established on Certain Streets.

(a) Maximum speed limits are established on portions of specific streets, as follows, and it shall be unlawful for any person to drive a vehicles on any part of a street where a maximum speed limit applies, at a higher speed than the maximum prescribed for that part of the street:

(b) Any person who violates any provision of this Section shall, upon conviction, be sentenced to pay a fine of Thirty-Five Dollars (\$35.00). Any person exceeding the maximum speed limit by more than five (5) miles per hour shall pay an additional fine of Two Dollars (\$2.00) for each mile in excess of five (5) miles per hour over the maximum speed limit.

SECTION 2. Any ordinance or parts of ordinances conflicting with the provisions of this Ordinance are hereby repealed insofar as they are inconsistent with this Ordinance's provisions.

SECTION 3. If any article, section, subsection, provisions, regulation, limitation, restriction, sentence, clause, phrase or word in this Ordinance, is, for any reason declared to be illegal, unconstitutional or invalid by any Court of competent jurisdiction, this decision shall not affect or impair the validity of this ordinance as a whole, or any other article, section, subsection, provision, regulation, limitation, restriction, sentence, clause, phrase, word or remaining portion of the within Ordinance. The Board of Supervisors South Heidelberg Township, Berks County, Pennsylvania, hereby declares that it would have adopted the within Ordinance and each article, section, subsection, provision, regulation, limitation, restriction, sentence, clause, phrase and word thereof, irrespective of the limitations, restrictions, sentences, clauses, phrases or word that may be declared illegal, unconstitutional or invalid.


SECTION 4. This Ordinance shall become effective at the earliest date permitted by law.
